Pursuant to Article 2, paragraph (1), item 106, and Article 5, paragraph (1), item 14 of the Ro ad Traffic Safety Act (Official Gazette Nos. 67/2008, 48/2010, 74/2011, 80/2013, 158/2013, 92/2014, 64/2015, 108/2017, 70/2019, 42/2020, 85/2022, 114/2022, 133/3, and 145/24), Article 35 of the Local and Regional Self-Government Act (Official Gazette Nos. 3 3/2001, 60/2001, 129/2005, 109/2007, 36/2009, 125/2008, 36/2009, 150/2011, 144/2012, 123/2017, 98/2019, and 144/2020), and Article 39 of the Statute of the City of Dubrovnik (Official Gazette of the City of Dubrovnik No. 2/21), the City Council of the City of Dubrovnik, at its 40th session held on 28 February 2025, has adopted the following:

Decision on Amendments and Supplements to the Decision on the Conditions for Entry to, Circulation Within, and Exit from the Traffic Zone in the Protected Historic Ensemble and Buffer Zone of the City of Dubrovnik

Article 1

In Article 12, paragraph 2, subparagraph 3 of the Decision on the Conditions for Entry to, C irculation Within, and Exit from the Traffic Zone in the Protected Historic Ensemble and Buffer Zone of the City of Dubrovnik (Official Gazette of the City of Dubrovnik 12/24; herein after: "the Decision") the second indent is replaced by the following:

" - submit a European Parking Card for persons with disabilities

Article 2 In Article 12, paragraph 3 of the Decision, the provision is replaced by the following:

"The application form (Form 3-1) is provided in the Annex to this Decision."

Article 3 A new Article 19a is inserted immediately after Article 19 of the Decision as follows:

"An offender referred to in Article 19(1)(1), concerning conduct in breach of Article 7(2) of this Decision, may, in place of the monetary sanctions provided in Article 19(3)–(5), be issued a warning.

Before issuing a warning, the City of Dubrovnik's official records shall be checked to establ ish whether the offender has previously committed the same offence and, if so, how many warnings have already been issued."

After checking the data referred to in paragraph 2 of this Article, a written warning may be issued to the offender if the general purpose of the administrative sanctions in the specific case can be fulfilled by a warning instead of a penalty.

When issuing the warning, the offender will be informed about the seriousness of the violation and the reasons for giving a warning instead of another prescribed sanction, and will be advised that they must comply with the applicable decision of the City of Dubrovnik in the future.

The City of Dubrovnik will keep a record of all warnings issued.

The record referred to in paragraph 5 of this Article shall contain the following:

- personal data of the offender;
- the time and place of the offence;
- the type of vehicle and its registration number;
- the legal provision defining the offence.

Article 4

By way of exception to Article 4, paragraph 1 of this Decision, and due to extraordinary circumstances, the Traffic Management System shall be applied in 2025 during the period from 2 June to 30 November.

This Decision on Amendments and Additions shall enter into force on the first day following its publication in the "Official Gazette of the City of Dubrovnik".
