

Pursuant to Article 35 of the Act on Local and Regional Self-Government ("Narodne novine," Nos. 33/01, 60/01, 129/05, 109/07, 125/08, 36/09, 150/11, 144/12, 19/13, 137/15, 123/17, 98/19, and 144/20), Article 5 of the Road Traffic Safety Act ("Narodne novine," Nos. 67/08, 48/10, 74/11, 80/13, 158/13, 92/14, 64/15, 108/17, 70/19, 42/20, 85/22, and 114/22), and Article 39 of the Statute of the City of Dubrovnik ("Official Gazette of the City of Dubrovnik," No. 2/21), the City Council of the City of Dubrovnik, at its 25th session held on October 21, 2023, adopted the following:

D E C I S I O N

on Amendments to the Decision on the Stopping and Parking of Tourist Buses and M1-Category Passenger Vehicles with a Capacity of (7+1) and (8+1) within the Special Traffic Regulation Zone.

Article 1

In the Decision on the Stopping and Parking of Tourist Buses and M1-Category Passenger Vehicles with a Capacity of (7+1) and (8+1) within the Special Traffic Regulation Zone ("Official Gazette of the City of Dubrovnik", Nos. 10/14, 18/15, 5/16, 8/16, 7/18, 6/19, 9/20, 14/21, 25/21, and 10/22), Article 8 is amended to read as follows:

"The parking fee for each individual instance of parking and stopping for passenger drop-off within the period from March 1 to November 30 of the current year is as follows:

- For M1-category passenger vehicles with a capacity of (7+1) and (8+1) 35.00 EUR
- For medium buses with 9 - 30 seats 70.00 EUR
- For large buses with more than 30 seats 140.00 EUR."

Article 2

In Article 8 b, Paragraph 5 is amended to read as follows:

The fee for the pass/sticker referred to in Paragraph 2, Subparagraph 5, marked as 'I' is 3,000.00 EUR, and the user of the pass/vignette may purchase a minimum of 5 (five) passes/vignettes.

Article 3

"In paragraph 1 of Article 14, the amount '10,000.00 kuna' shall be replaced by '1,320.00 euros.'

In paragraph 2, the amount '2,000.00 kuna' shall be replaced by '260.00 euros.'

In paragraph 3, the amount '5,000.00 kuna' shall be replaced by '660.00 euros.'

In paragraph 4, the amount '2,000.00 kuna' shall be replaced by '260.00 euros.'"

Article 4

"This Decision shall enter into force on the eighth day following its publication in the 'Official Gazette of the City of Dubrovnik,' except for the provisions of Articles 1 and 2, which shall enter into force on January 1, 2025.
